The creation of this prevention messaging campaign has been shared with other DFC's around the country. Additionally, the Coalition has expanded its reach from one neighborhood to a city wide reach. The Coalition has created several unique social marketing prevention messages such as Sippin Stupid and BARF focused on youth alcohol prevention.
