VICTIM LEGAL ASSISTANCE. SINCE 2003, NCVLI HAS BEEN LEADING THE NATIONAL EFFORT TO ENFORCE VICTIMS' RIGHTS THROUGH ITS CRIME VICTIMS' RIGHTS ENFORCEMENT PROJECTS. THESE PROJECTS ENSURE THAT VICTIMS HAVE ACCESS TO TRAINED NO COST (PRO BONO, AND LOW BONO) ATTORNEYS AND ADVOCATES TO SECURE FOR THEM MEANINGFUL RIGHTS THROUGH THE EXERCISE OF THOSE RIGHTS IN STATE, FEDERAL, MILITARY AND TRIBAL TRIAL AND APPELLATE COURTS NATIONWIDE. THIS PAST YEAR, ACCOMPLISHMENTS OF NOTE WERE MANY - SOME WERE ONGOING EFFORTS AND OTHERS AS NEW INITIATIVES. THE WORK OF THREE ONGOING PROJECTS ARE NOTED HERE.(CONTINUED ON SCHEDULE O)FIRST, TO ENSURE NATIONAL CAPACITY NCVLI CONTINUED PROJECTS THAT PROVIDE TRAINING AND TECHNICAL ASSISTANCE NATIONWIDE TO GROUPS CREATING AND OPERATING VICTIM LEGAL ASSISTANCE EFFORTS TO ENSURE SURVIVORS HAVE ACCESS TO LEGAL SERVICES AT NO COST WITH A FOCUS ON RIGHTS ENFORCEMENT.SECOND, NCVLI RESPONDED TO REQUESTS FOR LEGAL TECHNICAL ASSISTANCE (I.E., LEGAL RESEARCH, WRITING, AND STRATEGIC LITIGATION ADVICE) AND FILED AMICUS CURIAE (FRIEND OF THE COURT) BRIEFS IN CASES ACROSS THE COUNTRY. THIRD, NCVLI CONTINUED TO DEVELOP AND MAINTAIN ITS MEMBERSHIP ALLIANCE, THE NATIONAL ALLIANCE OF VICTIMS' RIGHTS ATTORNEYS & ADVOCATES (NAVRA), WHICH HAS A NATIONAL AND INTERNATIONAL MEMBERSHIP OF ATTORNEYS, ADVOCATES, AND STUDENTS. NAVRA PROMOTES THE EXCHANGE OF KNOWLEDGE AND RESOURCES TO FOSTER A NATIONAL NETWORK OF SKILLED ATTORNEYS AND ADVOCATES TO REPRESENT AND ASSIST CRIME VICTIMS IN THE CRIMINAL JUSTICE SYSTEM. NAVRA HAS A DEDICATED WEBSITE (WWW.NAVRA.ORG) WITH SEARCH DATABASES OF CASES, SAMPLE PLEADINGS AND LEGAL MEMORANDA. NAVRA ALSO ROUTINELY SPONSORS ONLINE CONTINUING LEGAL EDUCATION (CLE) OPPORTUNITIES. THERE WERE OVER 3,000 ATIVE MEMBERS REPRESENTING ALL 50 STATES.

OVER THE YEAR, NCVLI TRAINED ATTORNEYS, ADVOCATES, JUSTICE & ALLIED PROFESSIONALS ON THE MEANING AND ENFORCEABILITY OF VICTIMS' RIGHTS. THESE TRAININGS INCLUDED INTENSIVE IN-PERSON TRAININGS AND LECTURES, TECHNOLOGY-ASSISTED TRAININGS, AND VICTIMS' RIGHTS EDUCATIONAL MATERIALS.
