(E) The gas supply marketing/transportation services section committee shall have authority to plan, coordinate and direct activities benefiting gas supply marketing members. (F) The transmission section committee shall have authority to consider and deal with all matters pertaining to the transmission of gas from the source of supply to the distribution systems. (G) The associate member section committee shall plan and direct association activities benefiting associate members.
