UNICEF, through the UN Girls' Education Initiative and Education International (EI) will partner with Gender at Work to engage education unions in sub-Saharan Africa in a Gender Action Learning process. . This will contribute to a larger goal and continue beyond the life of the project, which is to use the findings of this pilot to engage other regions to enhance the safety and security of male and female children, youth and teachers in educational settings around the world.
