ADVOCACY INVOLVES HOSTING EVENTS FOR THE COMMUNITY, CREATING HANDOUTS AND REFERENCES FOR THE COMMUNITY AS WELL AS CO-HOSTING A PODCAST THAT EXPLORES THE ISSUES FACING THE COMMUNITY AND THE PEOPLE WORKING TO TRANSFORM THEM.
