WE MONITOR THE HUMAN RIGHTS ABUSES FACED BY IMMIGRANTS DETAINED BY ICE THROUGH A NATIONAL HOTLINE AND NETWORK OF VOLUNTEER DETENTION VISITORS, WHILE ALSO MODELING A COMMUNITY-BASED ALTERNATIVE TO DETENTION THAT WELCOMES IMMIGRANTS INTO THE SOCIAL FABRIC OF THE UNITED STATES. WE DOCUMENT, CATEGORIZE AND VERIFY, TO THE EXTENT POSSIBLE, HUMAN AND CIVIL RIGHTS ABUSES IN IMMIGRANT PRISONS AND JAILS ACROSS THE COUNTRY.
