PROJECT LEGACY'S WORK WITH AT-RISK YOUTH POPULATIONS IS FULL-SPECTRUM, AND THAT INCLUDES EDUCATION. AS WE ENTER THIS FALL AND A SCHOOL YEAR MARKED BY COVID-19 PRECAUTIONS, THAT COMMITMENT IS MORE IMPORTANT THAN EVER. ENTER LEGACY ACADEMY, THE UMBRELLA PROGRAM UNDER WHICH ALL OF PROJECT LEGACY'S ACADEMIC ENDEAVORS WILL OPERATE. PEOPLE WHO HAVE BEEN PROFESSIONALS IN WRITING, TEACHING, AND SCIENCE TURN UP WEEK AFTER WEEK TO HELP OUR YOUTH NAVIGATE THEIR WAY THROUGH ALGEBRA EQUATIONS AND HISTORY ESSAYS); WRITER'S WORKSHOP AND SPEAKER'S FORUM (LED BY WRITER BRYAN LUND AND SUPPLEMENTED BY CIVIC LEADERS, THIS PROGRAM EMPHASIZES THE POWER OF GOOD WRITING IN ALL ASPECTS OF LIFE, FROM THANK-YOU NOTES TO POETRY, FROM COLLEGE ENTRANCE ESSAYS TO MOCK-NEWS ARTICLES. THE SPEAKER'S FORUM PORTION OF THIS PROGRAM PUTS OUR YOUTH IN CONTACT WITH PEOPLE THEY CAN LOOK UP TO AND LEARN FROM: IN THE PAST YEAR OUR GROUP OF YOUNG WOMEN HAS PLAYED HOST TO LEGISLATORS, EDUCATORS, AND OTHER COMMUNITY ANCHORS. LEGACY SCHOLARS IS AN INNOVATIVE NEW PROGRAM DESIGNED TO HELP RETAIN AT-RISK STUDENTS AND YOUNG ADULTS OF COLOR THROUGH GRADUATION, HELPING PROVIDE SUPPORT, ASSISTANCE AND SKILLS TO CONTRIBUTE TO THEIR EDUCATIONAL SUCCESS. PROJECT RED UMBRELLA: PROGRAMMING FOR YOUNG WOMEN LEAVING THE SEX INDUSTRY OR HEALING FROM EXPLOITATIONPROJECT RED UMBRELLA IS A SPECIALIZED PROGRAM FOR YOUNG WOMEN AGES 17-28 WHO HAVE BEEN SEXUALLY EXPLOITED, ARE SURVIVORS OF SEX TRAFFICKING OR WHO ARE LEAVING THE COMMERCIAL SEX INDUSTRY. FOR YOUTH AND YOUNG ADULTS WHO HAVE BEEN SEXUALLY EXPLOITED, LEAVING THIS LIFE CAN BE FRIGHTENING. FOR MANY, IT'S THE ONLY LIFE THEY KNOW AND MANY WERE INTRODUCED TO IT AS MINORS. AS CHILDREN. ONE STUDY FOUND THAT AS MANY AS 60-90% OF YOUNG ADULTS WHO HAVE BEEN SEXUALLY EXPLOITED WERE SEXUALLY ASSAULTED AS CHILDREN. WE BELIEVE THERE IS A WAY OUT OF THIS LIFE AND INTO A LIFE OF HOPE, RESILIENCY AND HEALING. AT PROJECT LEGACY, WE HELP YOUNG PEOPLE NAVIGATING THIS CHANGE PROCESS THROUGH THE FOLLOWING SUPPORTIVE SERVICES, AT NO COST TO THEM: FACILITATED HEALING CIRCLE, SUPPORT 365 TO DEVELOP A PLAN FOR WELLNESS AND WHOLE-PERSON HEALING, CASE MANAGEMENT AND REFERRALS, PEER SUPPORT THROUGH A HEALTHY, ALTERNATIVE PEER GROUP, INDIVIDUAL THERAPY AND CRISIS COUNSELING, GED TUTORING AND PREPARATION, ASSISTANCE OBTAINING MEDICAL INSURANCE, MEETING BASIC NEEDS BY PROVIDING FOOD, CLOTHING, HYGIENE PRODUCTS, RENTAL ASSISTANCE, POST-SECONDARY AND VOCATIONAL COUNSELING, COLLEGE TUITION ASSISTANCE, EDUCATIONAL RESOURCES (LAPTOPS, PRINTERS, PHONES NEEDED FOR SCHOOLING), FINANCIAL LITERACY AND CREDIT COUNSELING.
