Fossil Free California's main campaigns target the California Public Employees Retirement System (CalPERS) and the California State Teachers Retirement System (CalSTRS) -- respectively the sixth and eleventh largest public pension funds in the world. Our campaigns call on CalPERS and CalSTRS to divest the more than \$20 billion of public employees' savings they have invested in money-losing oil, gas, and coal extraction companies. Board members, who have a fiduciary duty to pension fund members, and a sworn duty to protect all Californians, should be investing in a clean, green economy that addresses the looming climate crisis. Recognizing that California's \$3 trillion economy also includes substantial private assets that must be shifted away from the fossil fuel industry, our Move Your Money campaign helps individuals and organizations align their investing and banking with their values.

public pension funds in the world. Our campaigns call on CalPERS and CalSTRS to divest

the more than \$20 billion of public employees' savings they have invested in money-losing oil, gas and coal extraction companies.

Board members, who have a fiduciary duty to pension fund members and a sworn duty to protect all Californians, should

be investing in a clean, green economy that addresses the looming climate crisis.

2019 Highlights

- Allied with youth climate groups to apply significant public pressure to the CalSTRS Board.

**- Met individually with Board members, and won support for divestment by Fiona Ma, State Treasurer of California and ex officio member of
the Boards of both PERS and STRS.**

**- Launched campaign targeting California largest teachers' union, CTA, with a short video called "Our Pension, Our Planet" and the
hashtag #YourTeacherHasHomework.**

**- Continued to monitor CalPERS Investment Committee meetings and make public comments. Our critique of PERS' year-end report on
sustainable investing in response to state legislation (SB 964) was well-received and resulted in the report being revised.**

- Published the results of the report we commissioned from Corporate Knights that shows billions in losses from not divesting 10 years ago.

- Joined the large Last Chance Alliance coalition, supporting advocacy to Governor Newsom to use his Executive powers to transition California away from fossil fuels as soon as possible, and enact public health and safety regulations around fossil fuel extraction sites.

- Our Move Your Money campaign continues to educate individuals and companies about how to align investing and banking with their values. We were part of the coalition that succeeded in passing the California Public Banking Act in 2019, and we joined the national Stop the Money Pipeline coalition that targets banks, insurance companies, and asset managers for fossil fuel divestment.

- With ten short years to slash greenhouse gas emissions, our public pension funds - which represent 25% of the global capital market - could address the climate crisis and improve their returns by moving their capital out of fossil fuels and into more stable and lucrative investments that fund climate solutions. But the majority of pension investments continue to mirror passive indexes that include the failing traditional energy sector. With the tide of active investment turning against fossil fuels, the pension funds not only fuel the climate crisis with poorly-performing holdings; they also risk making our public employees the holders of last resort.
