In 2023, Fossil Free California demonstrated what momentum looks like in action:-Expanded our divestment coalition to180 organizations to support public pension divestment-Supported youth organizers attendance and power-building at two California Teachers Association State Councils which in turn resulted in three caucuses and several union locals publicly supporting divestment-Hosted a powerful webinar on the role of unions in pension divestment attended by over 100 union members statewide.-Earned extensive media coverage with over 50 articles by major news outlets including Bloomberg, POLITICO, Washington Post, and the Los Angeles Times.-Secured resolutions in support of public pension divestment by 13 unions, including CFT,California Faculty Association, AFSCME California, California Nurses Association, plus 5 cities.-Secured endorsements from Fiona Ma, Oakland City Attorney Barbara J. Parker, Bill McKibben, and the Institute for Energy Economics and Financial Analysis-Co-sponsored Climate Accountability Lobby day in support of SB 252, SB 253 and SB 261, which included over 150 participants and effected over 29 lobbying visits with current legislators.
