REGISTRANTS ON TBB’S TALENT CATALOG EXPANDED BY MORE THAN 40% BY THE END OF 2022. FROM JANUARY THROUGH OCTOBER 2022, MORE THAN 176 DISPLACED PEOPLE SECURED JOB OFFERS THROUGH TBB AND PARTNER PROGRAMS.
