THE BAIL PROJECT IS A NATIONAL NONPROFIT ORGANIZATION THAT PAYS BAIL FOR PEOPLE IN NEED, REUNITING FAMILIES AND RESTORING THE PRESUMPTION OF INNOCENCE. WE POST BAIL ON BEHALF OF OUR CLIENTS AND THEN HELP THEM RETURN TO COURT BY PROVIDING REMINDERS OF THEIR COURT APPEARANCES, HELPING SOLVE PROBLEMS THAT PREVENT APPEARANCES IN COURT, AND MAKING REFERRALS TO SERVICES ON A VOLUNTARY BASIS.

IN FY22, THE BAIL PROJECT MARKED FIVE YEARS OF OPERATIONS WITH NEARLY 24,000 INDIVIDUALS AND THEIR FAMILIES HELPED NATIONWIDE AND OVER \$65 MILLION IN FREE BAIL ASSISTANCE. THE BAIL PROJECT SUPPORTED THESE CLIENTS IN MORE THAN 80,000 COURT DATES FOR AN OVER 90% COURT APPEARANCE RATE, OFFERING FURTHER EVIDENCE THAT CASH BAIL IS NOT A NECESSARY INCENTIVE TO ENSURE THAT PEOPLE RETURN TO COURT. THIS HIGH RETURN TO COURT RATE ALSO CONTINUES TO ENSURE THE SUSTAINABILITY OF THE BAIL PROJECT'S NATIONAL REVOLVING BAIL FUND, WITH 92% OF BAIL PAYMENTS RETURNING AFTER CASES CLOSE. THIS SUCCESS ALLOWED THE ORGANIZATION TO LEVERAGE FUNDS TO HELP ADDITIONAL PEOPLE. IN FY22, THE BAIL PROJECT ALSO INVESTED IN A PILOT PROGRAM IN CHICAGO IN PARTNERSHIP WITH THE LAWNGDALE CHRISTIAN LEGAL CENTER TO LINK UP TO 3,000 PEOPLE WHO ARE RELEASED ON RECOGNIZANCE TO COURT NOTIFICATIONS, TRAVEL ASSISTANCE, AND VOLUNTARY SERVICES FOR EMPLOYMENT, HOUSING, MENTAL HEALTH, SUBSTANCE USE, VIOLENCE PREVENTION, MEDICAL CARE, AND OTHER SOCIAL SERVICE NEEDS.
