With our partner organization, Organization for Ethical Source (whom we also fiscally sponsor), we wrote and published an open source ethical intellectual property license available to software developers hoping to prevent their work product from being used in human rights abuses. We also took part in efforts to increase education and awareness around open source ethical licensing for software and other technologies.

4b (Code:) (Expenses \$ **174,079** including grants of \$) (Revenue \$)
We developed and used trade law strategies to combat forced labor in multiple industries and regions, including by conducting forced labor investigations, filing petition with Customs and Border Protection (CBP), challenging the importation of goods under Section 307 of the Tariff Act, and publishing reports on the successes and failures of human rights mechanisms in the cocoa industry in West Africa.

We designed and implemented a global transitional justice laboratory called the Corporate Liability and Sustainable Peace (CLASP) Lab that used design thinking processes to generate a variety of prototypes for addressing the crisis of corporate impunity in conflict settings. We also engaged in education and advocacy around transitional justice, including by providing reports and testimony to the Colombian transitional justice bodies and training Colombian attorneys on human rights civil litigation.
