Legal Design Lab and Transitional Justice: Developed and implemented innovative strategies to combat corporate abuse and impunity in global supply chains. Activities included: the execution of a global transitional justice laboratory that used design thinking processes to generate prototypes to address human rights and environmental harms across Latin America and Africa; piloting the use of new contract language to give workers legal rights when their labor rights are violated abroad; hosting virtual and in person convenings of lawyers and advocates from across the globe for cross-jurisdictional experience sharing and collaborative innovation.

4b (Code:) (Expenses \$ 258,613 including grants of \$ 200,000) (Revenue \$ 16,000)

Ethical IP: Supported the development of the Organization for Ethical Source, a community of software developers seeking to incorporate ethical standards into the tech industry. Activities included fiscal sponsorship of OES; provision of legal services (including development of a new software license containing ethical standards); and participation in education and outreach efforts.

Transform Trade: Leveraged international trade law to combat forced labor in multiple industries and regions across the globe. Activities included: conducting forced labor investigations; filing multiple petitions with US Customs and Border Protection under Section 307 of the Tariff Act; coordinating trade law strategies with partner organizations; convening a group of trade lawyers to brainstorm about human rights strategy; and publishing reports and blogs on forced labor in global supply chains.
