ADDITIONALLY, BTC WAS AWARDED PHASE 2 OF THE GATES GRANT, WHICH SUPPORTED THE DESIGN AND IMPLEMENTATION OF THE ALGEBRA 1 PILOT THAT LAUNCHED IN SUMMER 2022.
