PROGRAM & INNOVATION TEAM: IN FY2023 (JULY 1, 2022 - JUNE 30, 2023), THE PROGRAM AND INNOVATION TEAM LAUNCHED ITS BLACK LIBERATORY ALGEBRA I ACADEMY. AT LAUNCH, THE PROGRAM SERVED 25 BLACK ALGEBRA I EDUCATORS (TEACHERS AND COACHES) AND 12 SCHOOLS IN CLAYTON COUNTY PUBLIC SCHOOLS IN METRO ATLANTA. IN APRIL AND MAY OF 2023, AN EVALUATION WAS CONDUCTED ON THE FIRST YEAR OF THE PROGRAM. INTERVIEWS, FOCUS GROUPS AND SURVEYS SHOWED THAT THE ALGEBRA I ACADEMY, DURING ITS FIRST YEAR OF THE PROGRAM, INCREASED BLACK EDUCATORS' ADOPTION OF NEW ALGEBRA I INSTRUCTIONAL STRATEGIES, THEIR BLACK MATH TEACHER IDENTITY, AND THEIR FEELINGS OF COMMUNITY AMONGST FELLOW ALGEBRA I TEACHERS. IN THE SPRING OF FY2023 (JANUARY 2023 - APRIL 2023), THE PROGRAM AND INNOVATION TEAM CONTINUED ITS IMPLEMENTATION OF THE THE BLP I3 WORKSHOPS. SERVING 50 TEACHERS, THIS PROGRAM ENGAGED BLACK K-12 TEACHERS AROUND THE COUNTRY IN PEDAGOGICAL LEARNING GROUNDED IN THE BLP ELEMENTS. SURVEY RESULTS CAPTURING PROGRAM PARTICIPANTS' PERSPECTIVES ON THE I3 WORKSHOPS SHOW THAT THE MAJORITY OF PARTICIPANTS AGREED OR STRONGLY AGREED THAT THE WORKSHOP INCREASED THEIR LEARNING ON BLP AND WAS RELEVANT TO THEIR INSTRUCTIONAL PRACTICE AS BLACK TEACHERS. IN THE FALL OF FY2023 (SEPTEMBER 2023), THE PROGRAM AND INNOVATION TEAM LAUNCHED ITS BLACK LIBERATORY K-3 LITERACY PROGRAM. DESIGNED TO BRING TOGETHER THE SCIENCE OF READING AND BLACK LIBERATORY PEDAGOGY, THIS PROGRAM IS CURRENTLY SERVING APPROXIMATELY 20 K-3 TEACHERS IN LOUISIANA AND GEORGIA ACROSS 4 SCHOOLS. PRELIMINARY EVALUATION RESULTS (CURRENT PROGRAM EVALUATION UNDERWAY) SHOW THAT THE LITERACY ACADEMY IS HAVING A POSITIVE IMPACT ON TEACHERS' INCREASE IN KNOWLEDGE AROUND THE SCIENCE OF READING, INCREASE IN KNOWLEDGE ON BLACK LIBERATORY PEDAGOGY, AS WELL AS FOSTERING FEELINGS OF COMMUNITY AMONGST FELLOW BLACK K-3 TEACHERS

RESEARCH AND POLICY (RAP):IN FY2023 (JULY 1, 2022 - JUNE 30, 2023), THE RESEARCH AND POLICY (RAP) TEAM LAUNCHED THE INAUGURAL CLARK-WOODSON FELLOWSHIP. THE CLARK-WOODSON FELLOWSHIP PROVIDED AN OPPORTUNITY FOR BTC TO PARTNER WITH THE RESEARCH COMMUNITY, PARTICULARLY ACADEMICS TO STRENGTHEN AND ADVANCE RESEARCH AND SCHOLARSHIP CONCERNING BLACK EDUCATION. THROUGH THE FELLOWSHIP, BTC PARTNERED WITH TWO ACADEMICS, REPRESENTING THE UNIVERSITY OF ILLINOIS, URBANA-CHAMPAGNE AND THE UNIVERSITY OF DELAWARE, TO BOLSTER BTC'S RESEARCH AGENDA IN SERVICE OF FOSTERING BLACK LIBERATORY EDUCATION FOR BLACK STUDENTS, WHILE SIMULTANEOUSLY ADVANCING THEIR OWN SCHOLARSHIP.THE RAP TEAM COLLABORATED WITH THE PROGRAM & INNOVATION TEAM TO PLAY A PIVOTAL ROLE IN THE EVALUATION OF THE BLACK LIBERATORY ALGEBRA 1 ACADEMY. THE ACADEMY SERVED 25 BLACK ALGEBRA I EDUCATORS (TEACHERS AND COACHES) AND 12 SCHOOLS IN CLAYTON COUNTY PUBLIC SCHOOLS IN METRO ATLANTA. INTERVIEWS, FOCUS GROUPS AND SURVEYS SHOWED THAT THE ALGEBRA I ACADEMY, DURING ITS FIRST YEAR OF THE PROGRAM, INCREASED BLACK EDUCATORS' ADOPTION OF NEW ALGEBRA I INSTRUCTIONAL STRATEGIES, THEIR BLACK MATH TEACHER IDENTITY, AND THEIR FEELINGS OF COMMUNITY AMONGST FELLOW ALGEBRA I TEACHERS.IN ADDITION, THE RESEARCH AND POLICY (RAP) TEAM BROUGHT TOGETHER AN ASSORTMENT OF DATA EXPERTS TO SERVE AS A RESEARCH AND DATA ADVISORY BOARD. ADVISORY BOARD MEMBERS COMMITTED TO SERVE AS LONG-TERM CONSULTANTS TO PROVIDE UNIQUE EXPERTISE TO THE BLACK TEACHER COLLABORATIVE THAT MAY NOT BE OTHERWISE READILY AVAILABLE AND ENGAGE IN ROBUST CONVERSATIONS TO HELP DECISION MAKERS WITHIN THE ORGANIZATION CREATE BETTER-INFORMED CHOICES.
