NICJR PROVIDES CONSULTATION, PROGRAM DEVELOPMENT TECHNICAL ASSISTANCE, AND TRAINING TO AN ARRAY OF ORGANIZATIONS; INCLUDING GOVERNMENT AGENCIES, NON-PROFIT ORGANIZATIONS, AND PHILANTHROPIC FOUNDATIONS.

NICJR PROVIDES CONSULTATION, PROGRAM DEVELOPMENT TECHNICAL ASSISTANCE, AND TRAINING TO AN ARRAY OF ORGANIZATIONS; INCLUDING GOVERNMENT AGENCIES, NON-PROFIT ORGANIZATIONS, AND PHILANTHROPIC FOUNDATIONS.

JUSTICE REFORM -NEIGHBORHOOD OPPORTUNITY AND ACCOUNTABILITY BOARD (NOAB): IN FY22, NICJR CONTINUED TO GROW AND REFINE THE OAKLAND NOAB. UNDER NOAB, YOUTH ACCUSED OF NONVIOLENT FELONIES ARE DIVERTED AT THE POINT OF ARREST, APPEARING WITH THEIR FAMILIES BEFORE NEIGHBORHOOD-LED COUNCILS TO CO-DEVELOP INDIVIDUAL ACHIEVEMENT PLANS THAT INCLUDE INTENSIVE MENTORSHIP AND CONNECTIONS TO COMMUNITY-BASED SERVICES. THE NOAB MODEL FOCUSES ON RESTORATIVE, RATHER THAN PUNITIVE PRACTICES; INCREASES COMMUNITY INVOLVEMENT IN DECISION-MAKING; AND INVESTS RESOURCES IN YOUTH, FAMILIES, AND NEIGHBORHOODS. IN PILOTING NOAB, NICJR IS ESTABLISHING AN INNOVATIVE MODEL THAT CAN BE REPLICATED NATIONALLY. FY22 WAS A YEAR OF SIGNIFICANT GROWTH FOR THE OAKLAND NOAB, WITH THE PROGRAM RECEIVING 17 REFERRALS FROM THE OAKLAND POLICE DEPARTMENT. IN SEPTEMBER 2021, THE PROGRAM BROUGHT ON A FULL-TIME LIFE COACH WHO IS AN OAKLAND NATIVE AND FORMER HIGH SCHOOL FOOTBALL COACH WITH EXTENSIVE EXPERIENCE WORKING WITH YOUTH. THE PROGRAM ALSO EXPANDED ITS NETWORK OF CREDIBLE MESSENGERS AS WELL AS COLLABORATED WITH COMMUNITY MEMBERS TO INCREASE SUPPORT FOR YOUTH REFERRED TO NOAB. FOR EXAMPLE, IN DECEMBER 2021, THE PROGRAM HOSTED A HOLIDAY LUNCHEON THAT BROUGHT TOGETHER NOAB YOUTH AND THEIR FAMILIES, SMALL BUSINESS OWNERS, AND COMMUNITY MEMBERS FOR A DISCUSSION AROUND VIOLENCE IMPACTING SURROUNDING NEIGHBORHOODS. ADVOCACY: NICJR IS FUNDED BY THE CALIFORNIA ENDOWMENT TO CARRY OUT ADVOCACY WORK FOCUSED ON JUVENILE JUSTICE REFORM IN CALIFORNIA. WITHIN THE SCOPE OF THIS GRANT, IN FY22, NICJR CONTINUED TO ACTIVELY PARTICIPATE IN SEVERAL ADVOCACY COALITIONS THAT BRING TOGETHER GRASSROOTS ORGANIZATIONS, ADVOCATES, AND IMPACTED INDIVIDUALS TO WORK TOWARD JUSTICE REFORM. THROUGH THESE COALITIONS, IN 2022 NICJR TOOK A LEADING ROLE IN ADVOCATING FOR THE CREATION OF A STATEWIDE CALIFORNIA OFFICE OF VIOLENCE PREVENTION; SOLIDIFYING SUSTAINED CALIFORNIA VIOLENCE INTERVENTION AND PREVENTION FUNDING; AND, IN ALAMEDA COUNTY, REIMAGINING YOUTH JUSTICE AND EXPANDING ASSEMBLY BILL 109 FUNDING ELIGIBILITY.

GUN VIOLENCE REDUCTION ADVOCACY - IN FY22, NICJR SUPPORTED 16 JURISDICTIONS IN PLANNING, IMPLEMENTING, AND REFINING DATA-DRIVEN, EVIDENCE-BASED GVRs. EXAMPLES OF THIS WORK INCLUDED: WASHINGTON, DC: IN FY22, NICJR ADVANCED OUR GVRs WORK IN DC THROUGH THE RELEASE OF SEVERAL KEY PUBLICATIONS. BUILDING UPON OUR LANDSCAPE ANALYSIS OF VIOLENCE PREVENTION EFFORTS IN DC (PUBLISHED MAY 2021), NICJR PARTNERED WITH THE DC CRIMINAL JUSTICE COORDINATING COUNCIL (CJCC) TO CONDUCT A DETAILED ANALYSIS OF GUN VIOLENCE IN THE DISTRICT THAT WAS RELEASED IN FEBRUARY 2022. NICJR ALSO PARTNERED WITH PEACE FOR DC TO CONDUCT A COST OF GUN VIOLENCE ASSESSMENT. THE REPORT, PUBLISHED IN APRIL 2022, CALCULATED THE DIRECT COSTS OF GUN VIOLENCE TO DC TAXPAYERS. IN RESPONSE TO THESE REPORTS, THE MAYOR ANNOUNCED A NEW PROMISED PEOPLE INITIATIVE TO FOCUS INTENSIVE INTERVENTION EFFORTS ON THE PEOPLE AT HIGHEST RISK OF BEING INVOLVED IN GUN VIOLENCE. NICJR DEVELOPED A VIOLENCE REDUCTION STRATEGIC PLAN THAT WAS RELEASED IN APRIL 2022 BY THE CJCC. THE MAYOR'S OFFICE PLEDGED TO IMPLEMENT THE PLAN WITH NICJR'S SUPPORT. INDIANAPOLIS: FOR SEVERAL YEARS, NICJR WORKED CLOSELY WITH THE CITY OF INDIANAPOLIS TO CONDUCT A SERIES OF ASSESSMENTS AND DEVELOP PLANS THAT EVENTUALLY LED TO THE IMPLEMENTATION OF A GVRs IN JANUARY 2022. NICJR HAS SUPPORTED THE STRATEGY'S IMPLEMENTATION, INCLUDING BY TRAINING NEARLY 50 NEW STREET OUTREACH WORKERS, INTENSIVE LIFE COACHES, AND VIOLENCE INTERRUPTERS HIRED BY THE CITY. NICJR ALSO SUPPORTED THE INDIANAPOLIS POLICE DEPARTMENT IN RESTRUCTURING ITS OPERATIONS TO HAVE GREATER FOCUS ON GUN VIOLENCE AND TO MORE EFFECTIVELY SHARE INFORMATION WITH COMMUNITY VIOLENCE INTERVENTION WORKERS.

OFFICES OF VIOLENCE PREVENTION - WITH CONTRIBUTIONS FROM WALMART, MICROSOFT, JOYCE FOUNDATION, THE NATIONAL OFFICES OF VIOLENCE PREVENTION NETWORK LAUNCHED IN FEBRUARY 2021 WITH 21 MEMBERS. IT IS A FIRST-OF-ITS-KIND LEARNING COMMUNITY DESIGNED TO BUILD THE EXPERTISE AND CAPACITY OF OFFICES OF VIOLENCE PREVENTION AND OTHER SIMILAR AGENCIES THROUGH REGULAR VIRTUAL CONVENINGS AND TAILORED INDIVIDUAL TA, WITH IN-PERSON CONVENINGS PLANNED FOR THE FUTURE.
