Civic Digital Fellowship:The Civic Digital Fellowship is a 10-week-long internship program for software engineering, data science,product management, and design studentsboth at the undergraduate and graduate levelto solve innovation challenges in theUnited States federal government. Fellows receive a living stipend, housing, and roundtrip domestic travel to and from Washington, D.C., as well as exposure to the civic technology ecosystem through professional programming. For its Summer 2020 cycle, the Civic Digital Fellowship received 895 applications from 205 colleges and universities. 62 Fellows were selected and placed at eight federal agencies to improve their technical capabilities. After the Fellowship,Fellows reported feeling more prepared to enter the technology workforce upon graduation, with significant increases in the proportions feeling moderately prepared (from 41% to 51%) and extremely prepared (from 11% to 24%).

4b (Code:) (Expenses \$ 125,840 including grants of \$ 111,750) (Revenue \$)
First Act Fund:The First Act Fund provides catalytic funding and support to mission-driven young people with early-stage ideas to create impact with technology. During this fiscal year, Coding it Forward provided 16 grants, ranging from \$2,500 dollars to \$10,000 dollars, to 16 teams of innovators. In addition to the grant, these grantees received guidance from the Coding it Forward team in the form of educational content about product design and development, regular check-ins, and connections to the organizations network and mentor directory. These grants allowed teams to make initial investments in their team growth and product development; form partnerships with research groups, government entities, and accelerators; and receive additional external funding opportunities valued at hundreds of thousands of dollars.

4c (Code:) (Expenses \$ 50,535 including grants of \$) (Revenue \$)
Civic Innovation Corps:The Civic Innovation Corps is a new program mobilizing the next generation of technologists to create civic impact in cities and states across the country. Through 10-week internships, student technologists will work at state and local government offices and receive a competitive stipend, professional development opportunities, and access to a community of mission-driven peers.

(Code:) (Expenses \$ 30,514 including grants of \$) (Revenue \$)
Impact Fellowship:The Impact Fellowship recruits and matches entrepreneurial software engineers, product managers, and designers to spend a year with a host organization working on a pressing societal problem. In partnership with Schmidt Futures and the Federation of American Scientists, Coding it Forward placed six Impact Fellows in the programs inaugural cohort. The Impact Fellows worked in Product Management and Data Science roles across organizations including Code for America, Recidiviz, the MIT Media Lab, and UN Global Pulse. Through the duration of their Fellowship, Fellows received a competitive salary, professional support from the Coding it Forward team, and exposure to the broader public interest technology ecosystem through events and mentorship. The results of the program will be shared in the next fiscal years 990 as the inaugural cohort finished in August 2021.
