IN FY20, SPEECH FIRST FILED THREE MOTIONS TO INTERVENE IN FEDERAL TITLE IX LAWSUITS, FILED AND SETTLED A FEDERAL LAWSUIT AGAINST IOWA STATE UNIVERSITY, SETTLED ITS LAWSUIT AGAINST THE UNIVERSITY OF TEXAS, AND CONTINUED ITS LITIGATION AGAINST THE UNIVERSITY OF ILLINOIS, ALLEGING THAT VARIOUS POLICIES VIOLATED STUDENTS' FIRST AMENDMENT RIGHTS THROUGH OVERBROAD, VAGUE POLICIES DESIGNED TO CHILL STUDENT SPEECH AND EXPRESSION.
