IN FY22, SPEECH FIRST FILED A FEDERAL LAWSUIT AGAINST THE UNIVERSITY OF HOUSTON ON BEHALF OF ITS STUDENT MEMBERS ALLEGING ITS POLICIES VIOLATED STUDENTS' FIRST AMENDMENT RIGHTS THROUGH OVERBROAD, VAGUE POLICIES DESIGNED TO CHILL STUDENT SPEECH AND EXPRESSION.
