	IN FY24, WE FILED A LAWSUIT AGAINST INDIANA UNIVERSITY IN THE U.S. DISTRICT COURT FOR THE SOUTHERN DISTRICT OF INDIANA ON BEHALF OF OUR STUDENT MEMBERS CHALLENGING THE UNIVERSITY'S BIAS RESPONSE TEAM. IN THE COURSE OF THIS LITIGATION, WE APPEALED TO THE 7TH CIRCUIT COURT OF APPEALS AND ALSO FILED A PETITION FOR WRIT OF HABEAS CORPUS WITH THE U.S. SUPREME COURT. SPEECH FIRST SUED THE BIDEN ADMINISTRATION IN THE NORTHERN DISTRICT OF ALABAMA IN PARTNERSHIP WITH THE STATES OF ALABAMA, FLORIDA, GEORGIA, SOUTH CAROLINA, PARENTS DEFENDING EDUCATION, AND THE INDEPENDENT WOMEN'S FORUM TO CHALLENGE THE ADMINISTRATION'S TITLE IX REWRITE; THIS CASE WAS APPEALED TO THE 11TH CIRCUIT COURT OF APPEALS. IN ADDITION, OUR LAWSUIT AGAINST TEXAS STATE UNIVERSITY WAS ARGUED AND WON BEFORE THE 5TH CIRCUIT COURT OF APPEALS. FEDERAL LAWSUITS AGAINST OKLAHOMA STATE UNIVERSITY AND VIRGINIA TECH UNIVERSITY WERE BOTH SETTLED. SPEECH FIRST ALSO PRODUCED RESEARCH STUDIES, STATE-LEVEL MODEL LEGISLATION, RAPID RESPONSE CAMPAIGNS TO PRESSURE UNIVERSITY ADMINISTRATORS TO REVISE SPEECH-SILENCING POLICIES ON CAMPUSES, AND SPOKE TO MULTIPLE STUDENT ORGANIZATIONS ACROSS THE COUNTRY.
