In Erie, PA United worked to ensure that new development projects prioritize transparency, community benefits, living wages, and local and minority hiring. In Beaver County, PA United brought together community members from across the county to address the impacts of new extraction industry development. In Westmoreland County, PA United led the way on equitable COVID testing and vaccinations, as well as brought community input to the decisions about how to spend COVID stimulus funds. In Crawford County, PA United launched a new chapter to address the needs of residents for fair housing, investment in shared resources, and transparent government. PA United members worked tirelessly to create a new kind of politics, one where people who work the hardest and bear the greatest burden are the ones who are making decisions about their community.
