Register 2 Vote is a civic engagement organization with primary activities including voter registration and voter mobilization through ballot initiatives and issue advocacy.

Focus for Democracy: We made grants totaling \$687,000 to eleven organizations so that they could educate the public and policy-makers about the need for policies that protect democracy, including voting rights. Recipients used a variety of tactics, ranging from events that drew free media attention to television and digital ads and direct conversations with policy-makers on the subject.

4b (Code:) (Expenses \$ **70,934** including grants of \$) (Revenue \$)
Ground Game Texas: Ground Game Texas was founded in 2021 as an initiative to increase participation in civic engagement and voter turnout through the use of ballot initiatives. In 2021, Ground Game planned and developed multiple city ballot measure campaigns. These included planning a multi-city campaign in South Texas to promote ballot measures to adopt a \$15/hour minimum wage for city workers and city contractors, as well as an El Paso campaign to promote environmental action.

Voter Registration Mail Program: In 2021, Register 2 Vote ("R2V") worked to register voters by identifying voters who have moved but have not yet updated their voter registrations. R2V mailed these voters voter registration forms and/or directed them to their state online voter registration websites, as appropriate for each jurisdiction. These programs were primarily in Texas and Missouri.
