In 2022, Ground Game planned and developed multiple city ballot measure campaigns. These included planning a multi-city campaign in South Texas to promote ballot measures to adopt a \$15/hour minimum wage for city workers and city contractors, as well as an El Paso campaign to promote environmental action.
