IN COLLABORATION WITH OUR COMMUNITY, PARTNERS, AND DONORS, WE PROVIDE ESSENTIAL RESOURCES, SUPPORT, AND OPPORTUNITIES THAT EMPOWER CHILDREN AND SCHOOLS TO THRIVEHELPING THEM UNLOCK THEIR FULL POTENTIAL BOTH ACADEMICALLY AND IN THEIR BROADER LIVES, AT HOME AND WITHIN THE COMMUNITY. DURING 2024, EAT. LEARN. PLAY. ACHIEVED ITS MISSION THROUGH GRANTS AND PROGRAMS THAT SERVE OAKLAND YOUTH IN THE AREAS OF NUTRITION, LITERACY, AND PLAY. THROUGH OUR MOBILE RESOURCE CENTER AND PARTNERSHIP WITH ALAMEDA COUNTY COMMUNITY FOOD BANK, WE HOSTED 37 DISTRIBUTION EVENTS AT ELEMENTARY SCHOOLS AND COMMUNITY EVENTS WHERE WE DISTRIBUTED BOOKS AND FOOD TO 11,345 STUDENTS.HIGH-DOSAGE TUTORING WAS ALSO EXPANDED TO 1,911 STUDENTS AT 33 ELEMENTARY SCHOOLS AND A PILOT FOR LIBRARY RENOVATIONS WAS COMPLETED. WE ALSO PLANTED 29 OF OUR LITTLE TOWN LIBRARY BOOK-SHARING UNITS, WHICH, ALONGSIDE COMMUNITY PARTNERS, DISTRIBUTED OVER 14,000 CULTURALLY APPROPRIATE BOOKS. INCLUDING BOOK GRANTS, DONATIONS, AND HOLIDAY GIVEAWAYS, WE’VE DONATED OVER 165,000 BOOKS IN 2024.EAT. LEARN. PLAY.
