The organization provided workforce development job readiness training paid internships and skill building workshops for transgender and LGBTQIA+ youth and adults. Services included resume support interview preparation certification assistance and employer connections. Approximately 300 individuals were served during the year.

The organization provided housing navigation emergency hotel placement transportation support food assistance and personal hygiene supplies for individuals experiencing housing instability. Services prioritized transgender people facing immediate safety risks. Approximately 220 individuals received support.
