BECAUSE THE ORGANIZATION IS COMPRISED OF FORMER ELECTION ADMINISTRATORS WITH RCV EXPERIENCE, WE HAVE PROVIDED A UNIQUE PERSPECTIVE TO POLICYMAKERS. ADVOCATES ADDRESS THE "WHY" QUESTION, WHILE THE ORGANIZATION IS BETTER POSITIONED TO ANSWER THE "HOW" QUESTION.
