OUR DBA RANKED CHOICE VOTING RESOURCE CENTER (RCVRC) IS THE NATION'S ONLY ORGANIZATION DEDICATED SOLELY TO PROMOTING AND SUPPORTING THE ADMINISTRATION OF RANKED CHOICE VOTING (RCV). BECAUSE ELECTION OFFICES ARE OFTEN UNDERSTAFFED AND UNDERFUNDED, WE PROVIDE OUR EDUCATIONAL SERVICES AND TOOLS FOR FREE OR AT A NOMINAL FEE BASED ON STATE AND LOCAL POLICIES. RCV WAS USED STATEWIDE IN TWO STATES TO ELECT STATE AND FEDERAL OFFICIALS AND IN 11 CITIES ACROSS SEVEN STATES TO ELECT LOCAL OFFICIALS IN 2024. RCVRC STAFF SUPPORTED ELECTION STAFF IN MANY OF THESE JURISDICTIONS, PROVIDING EXPERT ADVICE ON IMPLEMENTING ORDINANCES AND REGULATIONS, PRESENTATIONS, CONSULTATIONS, TRAINING STAFF ON RCV AND RCTAB, AND ADVISING ON RCV IMPLEMENTATION BEST PRACTICES.
