A cohort of 3-5 empowered youth from across Flint and Genesee will serve a full year term. YGG will assist the youth council members on becoming environmental activists and help them build platforms to speak on EJ issues (political advocacy and community organizing) at a local, state, and national level. The Council will also be a representative of YGG when youth opportunities arise. There will be opportunities for in-person convenings like the Congressional Black Caucus Annual Legislative Conference and the annual Flint Weekend of Service.
