Voter Education: Expanded the voter education program by hiring and training campus fellows in predominantly Black communities. Fellows led voter education, registration, and mobilization activities, focusing on healthcare access and financial empowerment to drive year-round civic action, engaged over 48,000 community members during the general election, primarily in East Texas, and involved over 36,000 in advocacy efforts promoting health equity and economic justice.

Advocacy: Texas Fibroids Awareness Month: Hosted community self- care fairs in Beaumont, Dallas, and Fort Worth, reaching over 45,000 community members. The events provided no-cost health screenings, educational resources, and opportunities to support Black-owned and women-owned small businesses. Collected over 5,000 feminine hygiene supplies and donated them to Texas women's shelters in Dallas and Beaumont, as well as to a Black-majority high school in a low-income neighborhood in Fort Worth.
