In 2024 we worked on two ballot initiatives, one to provide paid sick leave to 250,000 Nebraskans who don't currently have paid sick leave at their jobs, and one to create a constitutional right to abortion up to fetal viability. For both projects, we helped build a coalition, supported leaders with lived experience, drafted policy language, raised funds, collected signatures, and educated voters.
