Each Campus Tour comes with one-on-one group training, national and local media press releases, 5-6 display panels, postcards, and the regional coordinator presence with the SFL group at the display. Campus Tours improve the quality of SFL groups through equipping and working with them one-on-one to engage their campuses in a direct manner.
