FROM FACILITATED SMALL GROUP SESSIONS TO OPEN TOWN HALLS, THE NONPROFIT ALLIANCE IS A SPACE FOR SENIOR LEADERS AND OTHER PROFESSIONALS TO GATHER TO EXCHANGE IDEAS AND CROWDSOURCE SOLUTIONS TO COMMON ISSUES.
