UNDER THE LEADERSHIP OF STAFF AND BOARD AND WITH THE SUPPORT OF VOLUNTEERS, THE NONPROFIT ALLIANCE CONTINUED TO GROW IN BOTH THE NUMBER AND VARIETY OF MEMBERS. THE CURRENT MEMBERSHIP COMPOSITION IS 60% NONPROFIT ORGANIZATIONS AND 40% PARTNER FIRMS AND CONSULTANCIES.
