EXPANDING MENTAL HEALTH ACCESSTHIS YEAR, RAICES SAGRADAS PROVIDED PROFESSIONAL MENTAL HEALTH CARE AT NO COST TO 186 INDIVIDUALS AND 67 COUPLES AND FAMILIESPRIMARILY IN SPANISH. OUR SERVICES TOTALED OVER 4,500 THERAPY SESSIONS, ALONG WITH 48 PSYCHOLOGICAL EVALUATIONS FOR COURT IMMIGRATION CASES. THE MARKET VALUE OF THESE SERVICES EXCEEDS \$855,000, ENSURING THAT LATINO FAMILIES IN NEED RECEIVE CULTURALLY COMPETENT, TRAUMA-INFORMED CARE WITHOUT FINANCIAL BARRIERS.STRENGTHENING OUR CLINICAL TEAMTO MEET THE GROWING DEMAND FOR MENTAL HEALTH SERVICES, WE EXPANDED OUR TEAM BY CONTRACTING TWO ADDITIONAL CLINICAL THERAPISTS, INCREASING OUR CAPACITY TO PROVIDE CONSISTENT AND ACCESSIBLE SUPPORT. ADDITIONALLY, WE WELCOMED TWO PART-TIME CLINICAL INTERNS, WHO HAVE ALREADY COMPLETED 150+ SUPERVISED CLINICAL HOURS, ENRICHING OUR THERAPEUTIC APPROACH WHILE DEVELOPING THE NEXT GENERATION OF CULTURALLY COMPETENT MENTAL HEALTH PROVIDERS.COMMUNITY MENTAL HEALTH EDUCATIONWE RECOGNIZE THAT HEALING EXTENDS BEYOND THERAPY ROOMS. THIS YEAR, WE HOSTED 18 COMMUNITY MENTAL HEALTH CONVERSATIONS, ENGAGING NEARLY 300 LATINO PARTICIPANTS IN DISCUSSIONS ON TRAUMA, RESILIENCE, AND EMOTIONAL WELL-BEING. THESE SESSIONS EQUIPPED INDIVIDUALS WITH KNOWLEDGE AND COPING STRATEGIES THAT RIPPLED THROUGH FAMILIES, FOSTERING A CULTURE OF HEALING AND SUPPORT ACROSS OUR COMMUNITY.EXPANDING AWARENESS THROUGH MEDIA & COMMUNITY ENGAGEMENTCULTURAL OUTREACH REMAINS AT THE HEART OF OUR WORK, ENSURING THAT UNDERSERVED COMMUNITIES HAVE ACCESS TO CRITICAL RESOURCES. THIS YEAR, WE DEEPEMED OUR PARTNERSHIPS WITH CONSULMEX SAINT PAUL AND MN LATIN RADIO, LEVERAGING MEDIA TO BREAK THE STIGMA SURROUNDING MENTAL HEALTH AND CONNECT SPANISH-SPEAKING INDIVIDUALS WITH ESSENTIAL SUPPORT SERVICES.BEYOND MEDIA OUTREACH, WE WERE ON THE GROUND, ACTIVELY ENGAGING WITH THE COMMUNITY AT 11 RESOURCE FAIRS, INCLUDING FIVE MAJOR LATINO-FOCUSED HEALTH EVENTS. THESE GATHERINGS ALLOWED US TO PROVIDE DIRECT ASSISTANCE, SHARE VITAL INFORMATION, AND FOSTER TRUST WITHIN THE COMMUNITIES WE SERVE. KEY EVENTS INCLUDED:- TU SALUD (TELEMUNDO MINNESOTA)- UNITY IN THE COMMUNITY (RICHFIELD POLICE DEPARTMENT)- YOUTH SPORTS RESOURCE FAIR (HENNEPIN COUNTY OUTREACH DEPT.)- HISPANIC HERITAGE CELEBRATION (MINNESOTA DEPARTMENT OF HEALTH)- URBAN VENTURES RESOURCE FAIR- FERIA DE SALUD (HIAWATHA COLLEGIATE HIGH SCHOOL)THROUGH THESE COLLECTIVE EFFORTS, WE ARE BREAKING BARRIERS, FOSTERING CONNECTIONS, AND ENSURING THAT FAMILIES HAVE THE KNOWLEDGE AND RESOURCES THEY NEED TO THRIVE.AT THESE AND OTHER COMMUNITY EVENTS, WE PROVIDED ESSENTIAL MENTAL HEALTH AWARENESS TOOLS AND REFERRALS.COMMUNITY EVENTS & SUPPORT NETWORKSRAICES SAGRADAS COLLABORATED WITH NEIGHBORHOOD DEVELOPMENT ALLIANCE (NEDA) AND LATINOS SERVING LATINOS TO HOST THE DÍA DE LOS MUERTOS CELEBRATION & CLOTHING DRIVE, PROVIDING ASSISTANCE TO 100+ INDIVIDUALS IN NEED. LATINO COMMUNITY LEADERS AND PARTICIPANTS UNITED IN A SPIRIT OF SOLIDARITY SHARING THEIR STORIES, FORGING MEANINGFUL RELATIONSHIPS, AND COLLECTIVELY ENVISIONING A BRIGHTER FUTURE.THIS SPECIAL GATHERING ALSO MARKED THE OFFICIAL LAUNCH OF THE RAICES SAGRADAS SUPPORT GROUP, A SAFE AND WELCOMING SPACE FOR MEANINGFUL CONVERSATIONS, MUTUAL SUPPORT, AND COLLECTIVE GROWTH. ATTENDEES ENGAGED IN POWERFUL NETWORKING OPPORTUNITIES AND A COLLABORATIVE 2025 VISION BOARD SESSION, SETTING INTENTIONS FOR THE YEAR AHEAD.LEADERSHIP REFLECTING OUR COMMUNITYTHIS YEAR, RAICES SAGRADAS REAFFIRMED ITS COMMITMENT TO DIVERSITY AND REPRESENTATION THROUGH THE ELECTION OF NEW TRUSTEES, WITH 90% IDENTIFYING AS LATINO. THIS ENSURES THAT OUR LEADERSHIP REMAINS CULTURALLY RESPONSIVE, COMMUNITY-DRIVEN, AND REFLECTIVE OF THOSE WE SERVESTRENGTHENING TRUST AND DEEPENING OUR IMPACT.
