IN FISCAL YEAR 2023, ROCKY MOUNTAIN PLANNED PARENTHOOD SERVED OVER 64K CLIENTS AT OUR 21 HEALTH CENTERS THROUGHOUT OUR THREE-STATE REGION - COLORADO, NEVADA, AND NEW MEXICO. THE MAJORITY OF OUR CLIENTS SEEK FAMILY PLANNING SERVICES SUCH AS CONTRACEPTIVES, PREGNANCY TESTING, GYNCOLOGICAL OR MID-LIFE CARE, AND LAB TESTS FOR PRE-CANCER SCREENING, HIV AND OTHER SEXUALLY TRANSMITTED DISEASES. THIRTY FIVE PERCENT OF OUR PATIENTS RECEIVED ABORTION SERVICES IN FY 2023. AN ESSENTIAL HEALTH CARE PROVIDER, OUR CLINICS ARE LOCATED IN HEALTH PROFESSIONAL SHORTAGE AREAS (HPSAS) AND MEDICALLY UNDERSERVED AREAS (MUAS) PPRM PROVIDED MEDICALLY NECESSARY HEALTHCARE TO PATIENTS. THIRTY SIX PERCENT OF OUR PATIENTS FALL AT OR BELOW 138 PERCENT OF THE FEDERAL POVERTY LEVEL. SEVENTY-SIX PERCENT OF PPRM'S PATIENTS ARE EITHER SELF PAY OR MEDICAID.
