THE GIVING PROJECT (GP), AN INNOVATIVE LEADERSHIP DEVELOPMENT PROGRAM TO TRAIN LEADERS TO MOBILIZE THEIR NETWORKS TO SUPPORT SOCIAL JUSTICE. UNLIKE TRADITIONAL FOUNDATIONS, CHINOOK USES THE INNOVATIVE GIVING PROJECT MODEL WHERE VOLUNTEERS LEARN ABOUT RACE, CLASS, AND SYSTEMS OF POWER, RAISE MONEY FROM INDIVIDUALS, CONDUCT SITE VISITS, AND DEMOCRATICALLY MAKE FUNDING DECISIONS DURING TWO GRANT CYCLES PER YEAR.
