COPA IS A MEMBER-LED ORGANIZATION BECAUSE WE BELIEVE THAT THOSE WHO ARE DIRECTLY IMPACTED BY THE ISSUES SHOULD BE LEADING THE WORK FOR CHANGE. IN 2020 WE ENGAGED COMMUNITY IN OUR EFFORTS TO ENSURE EVERY COLORADAN REGARDLESS OF THEIR ZIP CODE HAS ACCESS TO CLEAN AIR AND CLEAN WATER.
