THE EXECUTIVE DIRECTOR WAS OF THE UNDERSTANDING THAT A BOARD MEMBER, WHO IS NO LONGER ON THE BOARD, HAD TAKEN CARE OF ALL NECESSARY FILINGS, BUT UPON SEARCHING FOR THOSE FILINGS AND REACHING OUT TO THE PRIOR BOARD MEMBER, NO DOCUMENTATION OF FILINGS COULD BE FOUND.AS SUCH, PEOPLE'S PARITY PROJECT HAS ENGAGED THE SERVICES OF AN OUTSIDE FIRM TO BRING THE FILINGS INTO COMPLIANCE AND RESPECTFULLY REQUESTS THAT ANY ASSESSMENTS FOR LATE FILING BE WAIVED.
