EDITORIAL & GRAPHICS - IN 2020, THE MARKUP OFFICIALLY STARTED PUBLISHING INVESTIGATIONS AND REPORTS THAT REVEALED INEQUITIES AND HARM THROUGH TECHNOLOGY. OVER THE YEAR, THE MARKUP PUBLISHED 106 ARTICLES WHICH WERE CITED IN OVER 25 ACADEMIC JOURNALS AND REPORTS, INCLUDING THE INTERNATIONAL LABOUR REVIEW AND DATA & SOCIETY. THE RESULTS OF MARKUP INVESTIGATIONS WERE ALSO CITED IN HEARINGS IN THE US HOUSE OF REPRESENTATIVES, ANTI-TRUST LAWSUITS BY VARIOUS STATE COALITIONS AND THE DEPARTMENT OF JUSTICE, AND BY OTHER MEDIA OUTLETS, INCLUDING THE NEW YORK TIMES, CNN, AND CONSUMER REPORTS. THE SUBJECTS OF MARKUP REPORTING ALSO CHANGED THEIR BEHAVIORS INCLUDING, BUT NOT LIMITED TO, FACEBOOK REMOVING "PSEUDOSCIENCE" AS AN AD TARGETING TERM, MEANING THAT ADVERTISERS COULD NO LONGER TARGET 78 MILLION PEOPLE ACROSS THE PLATFORM. AFTER OUR INVESTIGATION IN JUNE 2020, AMAZON REMOVED NEARLY 100 DANGEROUS LISTINGS OF GUN PARTS, INJECTING DRUGS, AND OTHER DANGEROUS AND ILLICIT ITEMS. DURING THE PEAK OF THE CORONAVIRUS PANDEMIC, WE TESTED THE ACCESSIBILITY OF, AS WELL AS THE NUMBER OF THIRD-PARTY TRACKERS ON, ALL 50 STATE GOVERNMENT CORONAVIRUS WEBSITES. SUBSEQUENTLY, MULTIPLE STATES CHANGED THEIR SITES TO INCREASE ACCESSIBILITY AND REMOVED THE NUMBER OF TRACKERS ON THE SITE. IN ADDITION TO OUR INVESTIGATIONS INTO TECHNOLOGY COMPANIES AND THE ALGORITHMS THAT AFFECT OUR LIVES, THE MARKUP PUBLISHED ARTICLES IN OUR "ASK THE MARKUP" SERIES WITH DETAILED EXPLANATIONS INTO ARCAINE ISSUES OR TIMELY TOPICS. IN OUR FIRST YEAR, WE ANSWERED DOZENS OF QUESTIONS ACROSS A WIDE SPECTRUM OF SUBJECTS AND CONCERNS. SOME OF OUR MOST POPULAR INCLUDE "HOW PRIVATE IS MY PAY APP? AND "WHO'S ALLOWED TO TRACK MY KIDS ONLINE?"

PRODUCTION AND TECHNOLOGY - PART OF OUR UNIQUE NEWSROOM IS THE CREATION AND INNOVATION OF TOOLS TO HELP US INVESTIGATE BIG TECH AS WELL AS EMPOWER OUR READERS TO LEARN ABOUT HOW PRIVATE THEIR ONLINE ACTIVITY IS. WE BUILT CUSTOM, FORENSIC TOOLS LIKE BLACKLIGHT, WHICH SCANS WEBSITES TO REVEAL DIFFERENT METHODS OF ONLINE SURVEILLANCE AND TRACKING. SINCE ITS RELEASE OVER 2 MILLION SCANS HAVE BEEN PERFORMED BY OUR READERS AND THE LARGER PUBLIC. WE ALSO BUILT CITIZEN BROWSER, A DEMOCRACY DIAGNOSTIC TOOL, DESIGNED TO AUDIT THE FACEBOOK ALGORITHM TO SEE WHICH NEWS AND NARRATIVES THE SOCIAL MEDIA GIANT'S BLACKBOX ALGORITHMS AMPLIFY AND SUPPRESS. WITH THE RESULTS OF CITIZEN BROWSER, WE PUBLISHED MULTIPLE INVESTIGATIONS THAT REVEALED THAT FACEBOOK WAS OFTEN NOT KEEPING THE PROMISES IT MADE TO THE PUBLIC AS WELL AS THE US GOVERNMENT. SENATOR ED MARKEY, AND OTHER LEGISLATORS, HAVE CITED RESULTS FROM CITIZEN BROWSER IN HEARINGS AND LETTERS TO FACEBOOK AND ITS CEO MARK ZUCKERBERG. IN ADDITION TO THE PREVIOUSLY MENTIONED TOOLS, AS WELL AS EXTENSIONS LIKE SIMPLE SEARCH, WHICH HAS BEEN DOWNLOADED OVER 8,000 TIMES AND HELPS USERS REMOVE GOOGLE'S OWN PRODUCTS FROM THE TOP OF SEARCH RESULTS, THE MARKUP ALSO CREATES TOOLS FOR ITS OWN USE THAT PRIORITIZES OUR READERS' PRIVACY. WE'VE ESTIMATED THAT WE'VE SPENT AT LEAST \$57,000 TO BUILD CUSTOM FORMS, VIDEO PLAYER, DONATIONS PLATFORM, AND MORE TO MAKE SURE THAT OUR READERS' PRIVACY IS PROTECTED. WE LOOK FORWARD TO SHARING SOME OF THESE TOOLS, AS WELL AS DEVELOPING MORE TOOLS, WITH THE PUBLIC.

AUDIENCE - WE LAUNCHED META WITH THE MARKUP, A LIVE WEEKLY TALK SHOW, TO CONNECT DIRECTLY WITH OUR AUDIENCE AND CARRY OUR SHOW YOUR WORK ETHOS ACROSS THE ORGANIZATION. THE OVERARCHING THEME OF THE SHOW IS A DEEPER LOOK AT OUR REPORTING VIA OUR REPORTING TEAM WITH OCCASIONAL SPECIAL EPISODES DEVOTED TO SPECIAL PROJECTS, PRODUCT LAUNCHES, AND ORGANIZATION MILESTONES LIKE OUR FIRST ANNIVERSARY. WE HAVE ALSO HAD THE OPPORTUNITY TO EXPERIMENT WITH PLATFORMS TO FIND THE MOST NATURAL AUDIENCE AND STREAMLINE PRODUCTION AND REUSABILITY OF THE FOOTAGE. THIS LED US FROM INSTAGRAM LIVE, TO TWITCH, TO TWITTER SPACES.OUR BLACKLIGHT PRODUCT LAUNCH IN SEPTEMBER 2020 FEATURED REPORTERS, THOUGHT LEADERS, AND ARTISTS TO ENGAGE MULTIPLE POTENTIAL AUDIENCES IN CONVERSATION AROUND A SUBJECT CENTRAL TO THE MARKUP'S IDENTITY: ONLINE PRIVACY. FROM MONTH START TO FINISH, THE LAUNCH HELPED DRIVE ENGAGEMENT ACROSS SOCIAL MEDIA, RECORD FOOTPRINT GROWTH, AND A LIVE EVENT WITH OUR LARGEST CONSISTENT EVENT ATTENDANCE IN 2020. SINCE IT LAUNCHED, BLACKLIGHT AND OUR PROMOTION OF IT HAVE REMAINED CENTRAL TO OUR PUBLIC-FACING IDENTITY. THE LANDING PAGE IS ONE OF OUR TOP VISITED SITE PAGES IN THE LAST 12 MONTHS AND THE TOOL HAS GARNERED MORE THAN 2 MILLION SCANS OF WEBSITES ACROSS THE INTERNET, HELPING INFORM THE PUBLIC AND GIVE THEM AGENCY TO ENGAGE WITH BIG TECH. ADDITIONALLY, WE HAVE HEARD FROM FELLOW JOURNALISTS FROM MORE THAN ONE PUBLICATION THAT THEY ARE ACTIVELY USING THIS MARKUP-MADE TOOL TO INFORM THEIR OWN REPORTING.IN NOVEMBER 2020, THE AUDIENCE DEPARTMENT LED ON PROMOTING OUR PRESIDENT NABIHA SYED'S AMICUS BRIEF TO THE SUPREME COURT REGARDING VAN BUREN V. THE UNITED STATES. THROUGH DIRECT OUTREACH TO OUR OWN COMMUNITY'S INFLUENCERS AND A SMALL MERCHANDISE CAMPAIGN, WE BROKE THROUGH CONVERSATION BUBBLES TO GET THE CLEAR MARKUP MESSAGE THAT "SCRAPING IS NOT A CRIME" BEYOND OUR OWN COMMUNITIES AND INTO WIDER INTERNET CONVERSATIONS.
