OUR MASS BASE ORGANIZER PROVIDED ART- BASED ACTIVITIES AND MATERIALS TO ENGAGE YOUTH AND SUPPORT THEIR CREATIVITY USING ACTIVISM AS A FORM OF EXPRESSION THROUGH ART. OUR FOOD JUSTICE TEAM TENDED THE GARDEN AT PROJECT FEED THE HOOD AND PARTNERED WITH LOCAL SCHOOLS, GROUPS AND HERBALISTS TO GROW THEIR OWN FOOD AND MEDICINAL HERBS. OUR GENDER JUSTICE ORGANIZERS PROVIDED A SERIES OF BILINGUAL AND AGE- APPROPRIATE WORKSHOPS TO LOCAL YOUTH ABOUT FEMINISMS, RACISM, REPRODUCTIVE JUSTICE, BODY AUTONOMY AND LGBTQ TOPICS. OUR ENVIRONMENTAL JUSTICE ORGANIZER WAS INVITED TO ATTEND THE UNITED NATIONS CLIMATE CHANGE CONFERENCE IN GLASGOW WHERE THEY SPOKE ON THE IMPACTS OF THE MILITARY INDUSTRIAL COMPLEX, KIRTLAND AIR BASE'S POLLUTION AND WATER ISSUES. SWOP WORKED ALONGSIDE LOCAL COMMUNITY GROUPS LIKE PUEBLO ACTION ALLIANCE, TULAROSA DOWNWINDERS CONSORTIUM, YUCCA (YOUTH UNITED 4 CLIMATE CRISIS ACTION) IN SANTA FE TO ADDRESS ISSUES IN POLLUTION, CLIMATE AND ENERGY RELATED POLICIES. SWOP'S YOUTH JUSTICE PROGRAM FORMED PART OF THE NEW MEXICO YOUTH JUSTICE COALITION (NMYJC), TO CREATE COMMUNITY ALTERNATIVES TO YOUTH INCARCERATION AND COMBAT THE SCHOOL TO PRISON PIPELINE AND YOUTH CRIMINALIZATION. THESE YOUTH INTERNS WERE CONSULTED WITH BY THE OFFICE OF CYFD TO DETERMINE A BETTER FIT IN THEIR HIRING PROCESSES.
