OUR FOOD JUSTICE TEAM EXPANDED THE GARDEN AT PROJECT FEED THE HOOD AND PARTNERED WITH LOCAL SCHOOLS, GROUPS AND HERBALISTS TO GROW AND DISTRIBUTE PRODUCE AND MEDICINAL HERBS.
