Step Up Louisiana is a community-based organization committed to building power to win education and economic justice for all. We work with multiracial and intergenerational Louisianans to "Step Up" by campaigning, organizing from a racial justice perspective, and holding public officials accountable. We organize with parents, workers, students, and community members to disrupt systemic oppression in our schools and workplaces through voter education, advocacy, and action.

Throughout the pandemic, we began working on supporting unemployment workers and advocacy to improve the unemployment insurance system. Step Up also organizes with Dollar Store workers to improve wages and working conditions at major retail corporations in our communities.

We use door to door outreach and phone banking to inform voters about the issues at play impacted by elections. We also do voter engagement and community organizing year-round to hold our leaders accountable and keep our community informed.
