Observing Democracy is a novel and historic data initiative to strengthen democracy by partnering with the nation's leading data providers, civic groups, and media organizations to provide transparent, objective data on how citizens engage with the voting process. To support this work, the organization received in-kind contributions of licensed data, services, and compute resources valued at \$1.49 million: namely, licensed data contributions with net value of \$1,086,500; of licensed software valued at \$163,700; and data storage and compute resources valued at \$240,500.
