Through our service contractor in India we onboarded an additional 31 farms onto our Alliance For Responsible Aquaculture. We worked with farmers to improve their practices on the farm, particularly regarding lowering stocking densities to sustainable levels and improving water quality. We estimate that this program improved the lives of 720,000 fish.

Through our on-the-ground and desk research, we set an updated preliminary welfare standard, which can be found here: <https://www.fishwelfareinitiative.org/post/announcing-v2> This updated standard includes a stocking density cap, a fortnightly water quality evaluation, and improved feed management practices. We expect to implement this standard in our Alliance for Responsible Aquaculture in the coming year.

We completed a 6-month project in the Philippines where we worked on the ground with fish farmers to better understand what the animal welfare issues were and how we could fix them. We had significant levels of traction with the government through this project, as seen by the local governments co-hosting of our events and planned implementation of new fish farming ordinances. We also formed close relationships with local farmers, and estimate that we improved the lives of 10,000 fish.
