Our Research & Development Department conducted studies to improve fish welfare in India, including satellite monitoring of water quality, potential welfare improvements for fish at the nursery farming stage, and improved slaughter. We also developed a welfare assessment protocol for Indian major carps to enhance monitoring tools. Results from these studies are available on our blog and research pages at [www.fwi.fish/blog](#) and [www.fwi.fish/research](#).

We collaborated with local partners in China to host an Aquatic Animal Welfare Forum and 2 webinars discussing fish welfare. We also conducted in-country field visits and identified key welfare improvements for farmed fish in China. We continued building relationships with key Chinese stakeholders that will be significant for advancing the field and idea of fish welfare in China in the next years to come.

Through our on-ground staff in India, we supported 179 active farms in adopting higher welfare practices. These practices included lowering stocking densities to sustainable levels and improving water quality management. In 2025, we estimate that this program improved the lives of over 1.9 million fish.
