AND BUDGET EXPENDITURES. IN THE CASE THAT GRANT AWARDS ARE SPLIT INTO TWO PAYMENTS, A CHECK-IN CALL ON PROGRESS TOWARDS THE GRANT GOALS IS SCHEDULED BEFORE THE BALANCE OF THE GRANT AWARDED IS PAID OUT TO THE GRANTEE.
