Civic Engagement Beyond Voting works to engage and empower everyday Arizonans in every level of government in their state. By following the work of the state legislature, school boards, courts, and other boards and commissions, we inform the public of policies and actions that impact their lives. We seek to move Arizona forward with equity, education, justice, and progressive social ideals.

Our Program Service Accomplishments are as follows:1. TRAIN THE PUBLIC ON WRITING LETTERS TO THE EDITOR, SOCIAL MEDIA MESSAGING,TESTIFYING IN FRONT OF GOVERNMENT BODIES, AND OTHER ACTIONS OF CITIZEN ENGAGEMENTCEBV conducted 49 online trainings for general audiences about Arizona state and local government, writing Letters to the Editor, using messaging effectively, how to testify in public meetings, and water in Arizona, in addition to 2 dozen in-person presentations requested by a variety of interest groups in Arizona. Attendance varied from 10 people to nearly 200 per meeting, for an estimated 2500 people served. This work involved developing the one-hour trainings and toolkits, scheduling and promoting them through newsletters and social media, and delivering the trainings online or in person.TOTAL: \$18,7762. PRODUCE A WEEKLY ANALYSIS OF THE ARIZONA STATE LEGISLATION WITH ANALYSIS ANDINSIGHTS INTO PROCESSES AND PROCEDURESCEBV produced weekly legislative analyses during the Legislative session from January 7 through July 20, contextual descriptions of major issues being addressed, bills being considered, and actions that Arizonans can take to make their voices heard on issues that matter to them. The analyses were published on Substack and also summarized and highlighted in a weekly email to an audience of over 12,000 weekly subscribers and followers. TOTAL: \$29,0303. CONDUCT A YOUTH FELLOWSHIP PROGRAM TO PREPARE YOUNG PEOPLE AGED 16-22 FOR ENGAGING IN STATE AND LOCAL GOVERNMENTCEBV created and delivered two sessions of a 9-week Youth Fellowship program that included training on state government, county and local government, attending and speaking in a local public meeting, researching and critiquing Arizona laws and bills, interviewing an elected official, and numerous writing and speaking assignments. A total of 15 young people were trained and were paid \$1,500 stipends, and each delivered to a public online meeting their capstone project summarizing actions taken to develop a real-world program based on an issue with meaning for them.
