OUR GOAL IS TO FOSTER "UNLEARNING" THAT WHICH WE HAVE INTERNALIZED FROM OPPRESSIVE SYSTEMS AND ENCOURAGE PEOPLE TO RETHINK MENTAL HEALTH EDUCATION FROM A PLACE OF LIVED EXPERIENCE AND MULTIPLE VOICES.
