WITH THE GLOBAL PANDEMIC MAKING IN-PERSON EVENTS NO LONGER POSSIBLE THE EVENT PIVOTED TO A VIRTUAL FORMAT. WHAT THIS MEANT IS THAT PARTICIPANTS REGISTERED AS NORMAL BUT COMPLETED THEIR RUN VIRTUALLY IN THE PLACE AND TIME OF THEIR CHOOSING. THE COMMUNITY/CHARITY 5K WALK OR RUN,10K RUN AND KID'S FUN RUN DREW OVER 10,000 PARTICIPANTS CONTRIBUTING \$636,000 TO FIVE LOCAL CHARITIES: SECOND HARVEST SILICON VALLEY, HOUSING TRUST SILICON VALLEY, THE HEALTH TRUST, HEALTHIER KIDS FOUNDATION, AND SECOND HARVEST FOOD BANK SANTA CRUZ.

IN 2020 THE GLOBAL PANDEMIC AND SUBSEQUENT LOCKDOWN OCCURRED JUST DAYS BEFORE THE EVENT WAS TO TAKE PLACE. WE WERE ABLE TO PIVOT TO A VIRTUAL FORMAT VERY QUICKLY AND STILL DELIVER A VIRTUAL RUN FOR THE 1,700 PARTICIPANTS WHO HAD REGISTERED, 2,383 FOR THE RACE. AFTER ACHIEVING THE GOAL TO PLACE SALAD BARS IN EVERY SCHOOL WHICH APPLIED FOR THE PROGRAM, THE FOUNDATION DISTRIBUTED \$55,000 TO FUND YOUTH HEALTH AND EXERCISE PROGRAMS.
