WE ENGAGED 6,000 ATTENDEES AT COMMUNITY EVENTS, WHERE PERSONAL STORIES OF VOTING FOR THE FIRST TIME WERE SHARED, INSPIRING OTHERS TO MAKE THEIR VOICES HEARD.
